Dear Ms. Mackenzie and Members of the Search Committee,

I am writing to express my genuine interest in the Dean of University Libraries position at the University of Florida George A. Smathers Libraries. I feel my qualifications and experiences align extremely well with the expectations for this position and the qualities you are looking for in your next dean. I have enclosed my curriculum vitae for your review and would like to be considered as a strong candidate for this position.

My experience includes over 20 years of professional experience, having held progressively higher-level managerial positions at four R1 institutions. Since I arrived at The University of Alabama in 2015, I have focused on gaining new insights into organizational leadership and expanding my understanding of the broader issues facing research libraries and the academy at large. These opportunities have contributed to my growth as an administrator and have helped me develop a vision for how to best offer robust resources and expand library services into emerging areas. In addition to holding two terminal degrees, including a Master of Library Science and a Master of Public Administration, I have continued enhancing my leadership abilities by chairing and overseeing several projects, serving in various leadership roles, and participating in leadership training. I also was accepted into the SEC Academic Leadership Development Program for 2019-2020.

I believe strongly in professional growth, collaboration, and service at the university, state, and national levels, and I believe my experiences are a testament to that. I have served on professional committees within several associations including the Association of Southeastern Research Libraries, the American Library Association, and the Association for Research Libraries. I regularly represent the Dean of University Libraries at important regional and national meetings including the Association of Southeastern Research Libraries and the Center for Research Libraries. I am active at the state level through my service with the Network of Alabama Academic Libraries. Service to Alabama's academic libraries equally builds on my experiences at the University of Central Florida where I worked collaboratively within Florida as part of the Collection Planning Committee for the state university libraries with its focus on improved access to resources and cost containment. I am honored that my accomplishments at the University of Central Florida, and my participation at the state level, were recognized with promotion to Associate Librarian and the UCF Excellence in Librarianship award. I was also able to gain additional knowledge and contribute to improvements within the industry through service on several publisher advisory boards. I used these connections to influence product development related to content, delivery models, and improved user experiences.

A focal aspect of my work at The University of Alabama has been to manage internal processes, complete workflow analyses, and improve organizational dynamics to ensure seamless and consistent access to library resources and services. To meet those objectives, I have used various management techniques, encouraged employee growth and training, promoted employee empowerment, and focused on aligning department and individual goals with the strategic goals of the libraries and the university. I am committed to data-driven continuous improvement of workflows and processes while recursively seeking feedback from staff at all levels.

As a senior administrator, I have been actively involved with the \$300M Master Plan for University Libraries. This includes comprehensive renovation and new construction for the Amelia Gayle Gorgas Library (main), the University Libraries Archival Facility, Angelo Bruno Business Library which was featured in the 2023 Design Issue of *American Libraries*, and ongoing renovation to the Eric and Sara Rodgers Library for Science and Engineering. These concurrent projects have given me great insight into working with architects, engineers, and contractors at both the local and national levels.

I oversee the Angelo Bruno Business Library, The Eric and Sara Rodgers Library for Science and Engineering, University Libraries Special Collections, University Libraries Archival Facility, Research Data Services, and Research Computing in addition to my Faculty Affairs role as Senior Associate Dean. My experience leading faculty librarian liaisons, participating in instruction, and encouraging growth in programs and services has been instrumental in aligning specific goals with college and campus strategic initiatives, including the development and expansion of research data services and research computing over the past three years.

My experience overseeing both general and special collections has provided me with insight into best practices for expanding resources, improving discoverability and access, fundraising and fund stewardship, and assessing the overall value of collections in support of the teaching and research mission of the university. I have incorporated value metrics and key performance indicators to determine collection strengths and weaknesses. I am particularly proud to have designed, implemented, and managed a vibrant and comprehensive demand-driven acquisitions (DDA) program at The University of Alabama that has successfully transformed discovery and access to scholarly monographs. The success of this plan resulted in the transition to a new data-driven collection management strategy that emphasizes content at the point of need, ensuring that funds are more effectively expended in support of teaching and research. Similarly, I have directly negotiated several big package journal deals for the State of Alabama, leading the process for the state's research libraries, including those in the University of Alabama System, the Auburn University System, and the HBCUs.

Since I serve as the Senior Associate Dean of University Libraries and hold the tenured rank of Professor at The University of Alabama, I understand and appreciate the high-level expectations and rigor required of faculty librarian research and scholarship. I oversee the tenure and promotion process, guide and mentor faculty librarians, and serve as ex-officio on the Tenure Committee. I am currently working with 11 tenure-track faculty members in various stages of the process. During my time as Senior Associate Dean, six faculty members have successfully navigated tenure and/or promotion, including three reaching full professor. My efforts working with tenure-track faculty have helped University Libraries increase faculty scholarship as expectations for achieving tenure have risen. Our new standards have ensured the longevity of tenure and faculty rank for librarians and have engaged tenured faculty in the importance of continued research and scholarly output. Moreover, I always strive to lead by example and have continued to publish and present at the national level since my promotion to Professor in 2021. I also work closely with renewable contract (non-tenure) faculty during the hiring and contract renewal process to ensure

their success. I collaborated with the Dean of University Libraries and the Office for Academic Affairs to implement the first promotion process for renewable contract faculty in 2023.

As Senior Associate Dean, I oversee faculty hiring, develop new position descriptions, manage recruitment efforts, oversee search committees, complete reference checks, and deliver final hiring proposals to the Dean of University Libraries. During a time of robust growth and positive change within the college, I have overseen the hiring of 24 new faculty members. Likewise, almost 20 current faculty have accepted higher-level positions within University Libraries during this period, having been selected through competitive national searches as a result of their exceptional work. Retention efforts have included professional mentoring, support for professional travel, and collaboration with the Office for Academic Affairs to review and increase salaries based on Association for Research Libraries salary data. These efforts have resulted in very low faculty turnover rates during my tenure as Senior Associate Dean.

I am active on several committees and task forces that are critical to the college and university. Serving as the Associate Dean for Faculty Affairs and the Associate Dean for Research provides me with ample opportunities to be engaged in university-wide discussions, as does attendance at regular meetings of the Council of Assistant and Associate Deans. Within University Libraries, I am actively engaged with the University Libraries Strategic Planning Committee and chaired the SACSCOC Committee, which successfully completed its work earlier this year. I also oversee sponsored funding applications and awards and manage close to \$5M in currently active sponsored funding. Additionally, I serve as a co-PI on approximately \$3M worth of grants. Moreover, my extensive work with colleagues at the University of Florida and Florida State University, including regular meetings in Gainesville, has given me valuable statewide experience in Florida. This understanding of the significant role UF has within the state as the flagship university is an important factor in my interest and qualifications for the Dean of University Libraries position.

Throughout my career, I have been blessed to work with talented, creative, and progressive individuals who have made the libraries I work in a success. Much of what I have accomplished is the result of my willingness to collaborate and serve with accomplished individuals both within my organization and the larger profession. I believe that the preparation I have made throughout my career makes me an ideal candidate for the Dean of University Libraries position at the University of Florida George A. Smathers Libraries. I am very much looking forward to the opportunity to discuss my experiences, skill sets, and vision for the future of the George A. Smathers Libraries and to learn more through direct conversations with the talented faculty and staff that make the University of Florida such an incredible place to work.

The University of Alabama is the state's flagship institution with R1 status in the Carnegie Classification of Institutions of Higher Education that enrolls over 40,000 students. The University Libraries has a total operations budget of more than \$22 million and expends over \$12 million on collections annually. The library system includes 3 campus branches and a comprehensive Archival Facility that provides access to over 6.5 million volumes. The University Libraries has over 2,800,000 e-books, has over 5 million website views per year, and has a robust electronic collection that produces over 8 million database searches and 3.1+ million full-text downloads per year. The University Libraries memberships include ARL, CRL, ASERL, GWLA, IFLA, CNI, HathiTrust, and FDLP. Robust print, electronic and Special Collections, and facilities and virtual spaces are visited over 13 million times each year. In-demand research data services, data informatics programming, coding workshops, and cutting-edge information literacy programs help make University Libraries integral to the teaching and research mission of The University of Alabama.
